Textual Information()

This is with reference to requirement of minimum (25%) Public Shareholding. We wish to mention that as per notification dated 22.08.2014 of Ministry of Finance, Department of Economic Affairs, (the Securities Contracts (Regulation) (Second Amendment) Rules 2014) Provided that every listed public sector company which has public shareholding below twenty five percent, on the date of commencement of the Securities Contracts (Regulation) (Second Amendment) Rules, 2014, shall increase its public shareholding to at least twenty five percent, within a period of three years i.e. 21.08.2017, in the manner, as may be specified by the Securities and Exchange Board of India. Now, as per Ministry of Finance, Department of Economic Affairs notification dated 03/07/2017, (the Securities Contracts (Regulation)(Third Amendment) Rules,2017) quotes in rule 19A,in sub rule (1), in the proviso, for the words three years the words four years shall be substituted i.e. increase in public shareholding to at least twenty five percent by 21.08.2018. Bank had already taken approval through Special Resolution to Create, offer, issue and allot such number of Equity Shares of face value of Rs 10/- in aggregate up to Rs 1215 crore (Rupees One Thousand Two Hundred Fifteen crore Only) inclusive of such premium as may be fixed as per SEBI Guidelines or such other amount as may be approved by GOI & RBI, by way of Public Issue (i.e. Follow on Public Offer) / Right Issue / Qualified Institutional Placement(s) / and/or any other mode or a combination(s) thereof in one or more tranches within a period of twelve months or any other timeline specified by SEBI regulations subject to the condition that the GOI shareholding in equity capital of the Bank does not fall below 52% at any point of time. We submit that Bank will adhere to all timelines in compliance to regulation 38 of SEBI (LODR) Regulations, 2015 with respect to Minimum Public Shareholding.
