Reg: Notice for Strike by United Forum of Bank Unions on 22.08.2017

We have been informed by Indian Bank's Association that the convenor, United forum of Bank Unions (UFBU) have served a notice of strike dated 3rd August, 2017 informing their decision that all the members of the constituted unions of the united forum of the Bank Unions (AIBEA, AIBOC, NCBE, AIBOA, BEFI, INBEF, NOBW, INBOC & NOBO) propose to go on **All India One day Strike on 22nd August 2017.**

If the strike materialises, a certain section of the Bank's employees may participate in strike on the said date, in which case, it is likely that the normal functioning of the branches / offices of the Bank may get affected.

The Bank is taking all necessary steps in terms of the existing guidelines to deal with the strike and for smooth functioning of Bank's branches / offices.
