Application submitted in any other form/mode/incomplete application shall not be considered and would be rejected out rightly.
- 7. The Advocate/Law Firms should have adequate setup/infrastructure to deal with the matters.
- 8. Bank reserves the right to accept or reject any or all the applications at any stage of the process without assigning any reason thereof and no claim/dispute in this regard shall be entertained.
- 9. Mere submission of application/proposal for Empanelment does not itself entitle any applicant for Empanelment or confer any right to the Advocates/Law Firms to receive any work from the Bank.

For empanelment of Advocates, following factors are to be fulfilled:
