

# Govt overhauls norms for highway project preparation To Cap Max Score For Quoting Low Price

New Delhi: Amid the trend of private players quoting low prices to bag project preparation and supervision consultancy contracts, the road transport ministry has made sweeping changes in tendering norms.

As per the new rules, the ministry will cap the maximum score that bidders would get even if they quote abnormally low prices and there will also be a limit on how many contracts any consultancy firm, based on assessment of its capacity, can take at one point of time.

Recently, two probe reports on Silkyara tunnel collapse in Uttarakashi by the central and Uttarakhand governments pointed to preparation of "deficient" detailed project report (DPR), a trend that has become a cause of concern for government as well. TOI has learnt that the road transport ministry has circulated the amended norms to all highway owning agencies.

80% score on technical parameters. Then the average bid prices quoted by all the bidders will be worked out and any bidder quoting 25% less than the average prices will get the maximum score. This will bring bidders to a level playing field.

Sources said these provisions have been incorporated considering that the finance ministry guidelines specify that no bidder can be eliminated. "Till now companies that score less in technical qualification, which takes into account the qualified manpower on their roll and their past records, end up bagging projects after quoting very low prices. This resulted in less capable players getting more projects. Now it will change," said an official.
