TERMS AND CONDITIONS FOR STRONG ROOM.

1. The work to be completed within a period of 10 days from the date issuance of work order.
2. The bill will invariably contain product serial number along with a certificate that the product complies with latest BIS standard. BIS certification by way of a metallic label on each product on each individual item with serial number will be mandatory requirement for supply of Strong Room Doors with grilled gate. Labeling of such specification is mandatory and no other self-declarationz will substitute this provision.
3. The doors should have provision of sealing to avoid entering of water into the strong room while the door is closed and limit switch to disconnect the electrical supply to strong room once the door is closed.
4. The vendor is bound to buy back the old and non-BIS strong room door with grilled gate, if required by Bank.
5. Payment of the equipment shall be made by the Branch to the Supplier on receipt of the specified goods at the site and successful installation of the equipment provided no defects are observed.
6. No advance will be paid.
7. Liquidated Damages - If the supplier fails to deliver the Goods or does not perform the Services within the time period(s) specified in the Contract, the Purchaser shall, without prejudice to its other remedies under the contract, a sum equivalent to 1% per week of the delivered price of the delayed Goods or unperformed Services for each week of delay until actual delivery or performance, up to a maximum deduction of 10% of cost of equipment. Once, the maximum is reached, the Bank may consider termination of contract and shall be entitle to terminate it.
8. Incomplete tenders shall be rejected and no further communication in this regard will be entertained. The tenderer shall not make any correction/alteration on these documents. Over writing of figures is not permitted. Failure to comply with either of these conditions will render the tender void. No advice or any change in rates or conditions after submission of the tender will be entertained.
9. It is the responsibility of the vender to take all necessary safety / precautionary measures for the safety of your labours and Bank shall not be responsible in case any accident / mis-happening occurred to your labour during execution of captioned work.
10. The bidder should quote in figures as well as in words the rate and amount tendered by them. The amount for item should be worked out and the requisite totals to be given.
11. Selected bidder is required to organize the work in such a way that occupants of the flats/Building are put to no hardships and living conditions of the occupants are not affected. Selected Bidder is required to take adequate care during progress of work to protect belongings of occupants, furniture etc. in case of any damage, the same shall be made by vendors at their own cost. After completion of work cleaning of floors, furniture, etc. to be done up to the satisfaction of occupants.
12. The period of warranty shall start from the date of installation of above said items and warranty shall cover a period of minimum 1 year.
13. Transportation and installation will be vendor's responsibility. The rate quoted should be inclusive of all charges and exclusive of applicable taxes.
14. Payment will be made only after delivery and satisfactory installation of Strong room gate.
15. The lowest rate quoted will be selected.
